Heart Mountain Dressage Club is excited to invite riders of all levels, and horses of various breeds and abilities, to apply for this clinic, unique to this area. To apply, please complete the application to be postmarked or emailed by the closing date of May 31st. Our goal is to host a diverse mix of riders, horses and skill levels fostering a dynamic learning experience for riders and spectators. The clinic committee will review all applications with these goals in mind and notify the chosen riders by June 15th. Chosen riders must submit their full payment by June 30th to secure their spot or a substitute will be chosen from the waiting list. We encourage applicants to ride once each day and this will be a factor in selecting riders. Our clinic will proceed rain, snow, or shine. There will be no refunds (except if the clinic is cancelled) unless we can fill a spot from the waiting list. Auditors are free and always welcome. A total of 15 lessons will be available and one time slot on Sunday will be filled as a demonstration ride by the clinicians. The clinic will be held at the McCarty Ranch located at 57 Sunset Rim, Cody, Wyoming. Chosen applicants will be informed of stabling options, lodging, meals and required vaccination/health requirements closer to the event.

The team of Camille Judet-Cheret and Corentin “Coco” Pottier of Pamfou Dressage are international Grand Prix riders and trainers, and both are ranked highly by the FEI. Both have won French National Championships multiple times. Corentin has competed in the 2023 Nations Cup as part of the French team in preparation for the 2024 Olympics. Corentin is on the list for the French team for the 2024 Olympics. They train with 5* FEI judge Isabelle Judet (French team trainer for the Barcelona Olympics) and German trainer Norbert Van Laak (past team trainer for France, Denmark and Canada).
