

RELEASE OF LIABILITY AND INDEMNIFICATION

This **RELEASE OF LIABILITY AND INDEMNIFICATION** is entered into on the date noted below, by _____ (which can include auditor, participant or rider hereinafter referred to as "Rider"), and, if Rider is a minor, the parent/guardian of Rider _____. In consideration of the services provided by Farrah M. Green and Sitting Horse LLC, their agents, representatives or employees (herein referred to as "Instructor/Trainer") and for use of property, facilities, and services provided at 35 Corbett Road, Cody, Wyoming by Steven and Echo Youngbauer, their agents, representatives or employees (hereinafter referred to as "Owner"), the Rider, his/her heirs, assigns and legal representatives, hereby expressly agree to the following:

1. As stated in Wyoming Statutes 1-1-122 thru 1-1-123, I agree that horseback riding and all equine activities are inherently dangerous activities and that these activities will expose me to above normal risks of bodily injury and/or death.
2. I agree that I am responsible for my own safety while engaging in any and all equine activities and services provided by the Instructor/Trainer on or off of the Owner's property.
3. I agree to acknowledge all of Instructor/Trainer's and Owner's rules and regulations pertaining to any and all equine activities occurring on or off of the Owner's property and I agree to and am responsible for wearing protective gear appropriate for equine activities to ensure Rider's safety while engaging in such activities.
4. I understand the risks involved in equine activities and **I AGREE TO ASSUME ANY AND ALL RISKS INVOLVED IN THE SERVICES PROVIDED BY THE INSTRUCTOR/TRAINER AND THE RIDER'S USE OF OR PRESENCE UPON OWNER'S PROPERTY AND FACILITY AND I FURTHER AGREE TO INDEMNIFY AND HOLD HARMLESS INSTRUCTOR/TRAINER AND THE OWNER** while engaging in any equine activity without limitation and including the risk of death, bodily injury, property damage, falls, kicks, bites, unavailability of emergency medical care, and/or ordinary negligence and/or deliberate act of another person.
5. I agree not to sue the Instructor/Trainer or the Owner in association with any claims, damages, costs, or expenses arising out of the services provided by the Instructor/Trainer and/or the Rider's use of or presence upon Owner's property and facilities while engaging in any and all equine activities including those based on death, bodily injury, and property damage, unless the damages are caused by the direct, willful and intentional gross negligence of the Instructor/Trainer or Owner.
6. Rider is responsible for complete and full insurance coverage on himself/herself, personal property, and Rider's horse.
7. Rider and Rider's parent or guardian, (if Rider is a minor) agree that this Release of Liability and Indemnification will be legally binding to my legal representatives, guardians, assigns and heirs and shall be enforced and interpreted under the laws of the State of Wyoming.
